Accessibility statement

Bureau Veritas undertakes to make its website accessible in accordance with Article 47 of Law No. 2005-102 of February 11, 2005.

To this end, it shall implement the strategy and actions detailed in its multi-year plan which is currently being drawn up.

COMPLIANCE STATUS

The Bureau Veritas site is not compliant with WCAG 2.1 Double-A (AA) level due to the non-conformities and deviations listed below.

TEST RESULTS

The compliance audit carried out by [Ipedis](#) reveals that the compliance rate is 32,50%:

- 13 compliant criteria
- 27 non-compliant criteria
- 10 non-applicable criteria

NON-ACCESSIBLE CONTENT

The contents listed below are not accessible for the following reasons.

Non-compliance

Several elements of non-compliance are described in this document, some of which are recurrent on several pages:

- Images do not have relevant alternatives.
- Videos do not have subtitles or audio description.
- Videos do not have a transcription for screen readers.
- Some items should be on a list.
- The reading order is not correct.
- Personal information input fields do not have autocomplete options.
- Color is used as the only means of conveying information
- Some text is not contrasted enough.
- Not all page elements remain visible and functional, even when zoomed to 200% or more.
- Page elements do not remain visible and accessible, even when the window width is reduced to 320px.
- Some layout elements are not contrasted enough.
- When the text style properties are changed, there is a loss of content in places.
- Some elements are not reachable with the keyboard tabulation.
- It is not possible to exit certain components or navigate within them with the keyboard.
- There is no way to pause certain elements.
- The titles are not relevant.
- The function of links is not determined by the text or the context.
- Headings and labels do not describe the subject or purpose.
- Elements do not have a visible keyboard focus.
- Language change is not specified with a lang attribute and a relevant language code.
- Forms do not explicitly indicate all mandatory fields not filled in with error messages.
- Form fields do not have a linked label.
- Form fields do not have suggestions for error correction.
- Not all elements are nested according to their specifications.
- Some iframes do not have a Title attribute.
- Some components do not have explicit titles.

- Some texts are not transmitted to the screen reader.
- Status messages are not relayed to screen readers.
- The style is not defined in a stylesheet but in the HTML.
- PDF documents are not properly structured.
- The page does not use a consistent title hierarchy.
- Some modals do not have a role="dialog" attribute.

Derogations for disproportionate burden

Content not subject to the obligation of accessibility

The content of the "Cours de l'action" page is placed in an iframe hosted outside the site. Its content is therefore not subject to the Bureau Veritas site accessibility obligation.
